# DAGMARS MARINA ENVIRONMENTAL POLICIES

Dagmars Marina is committed to environmental stewardship and compliance with all applicable regulations, including Chapter 90.48 of the Revised Code of Washington (RCW), the Federal Water Pollution Control Act (Clean Water Act), and Title 33 United States Code, Section 1251 et. seq. All vessel owners, tenants, contractors, and vendors must adhere to the following **Best Management Practices (BMPs)** to protect water quality and ensure sustainable marina operations.

## **Best Management Practices (BMPs)**

### **General Responsibilities**

- **BMP-1**: Before performing any work, boat owners, agents, employees, contractors, and subcontractors (Boatyard Users) must read and agree to comply with these BMPs as outlined in the standard user agreement.
- **BMP-2**: Violations of BMPs may result in termination.

Additional penalties, cleanup costs, or legal consequences resulting from violations will be the responsibility of the violator. Offenders may be permanently banned from the boatyard or marina.

• **BMP-3**: All work involving stripping, sanding, scraping, painting, coating, or varnishing is allowed in designated areas only. Loose material on the ground must be cleaned up immediately.

#### **Hazardous Materials & Waste Management**

- **BMP-4**: Paints, solvents, and chemicals **must not** be stored on the ground under or around boats.
- **BMP-5**: Drip pans and absorbent pads must be used for all petroleum transfers. Any spills must be cleaned immediately, and the Marina must be notified.
- BMP-6: No containers larger than five (5) gallons are allowed in the boatyard.
- BMP-7: Paints, solvents, and chemicals must be stored in weather-proof secondary containers.
- **BMP-8**: Bilges must be cleaned **before** any work that penetrates the hull.
- **BMP-9**: The discharge of **oil**, **fuel**, **bilge water**, **sewage**, **or greywater** into the marina is strictly prohibited. Use only approved vendors for holding tank pump-out services.
- **BMP-10**: Vessel washing is **only allowed** in designated washdown areas.

#### **Contractor & Waste Disposal Requirements**

- BMP-11: Contractors and boatyard users are responsible for proper waste disposal.
  - No waste may be dumped into storm drains.
  - o Solid, non-hazardous waste may be placed in marina trash cans.
  - Hazardous materials, including used oil, antifreeze, fuel, solvents, paints, varnish, and batteries, must be disposed of properly and may not be placed in marina trash cans.
  - o Empty containers must be disposed of correctly.

#### **Prohibited Practices & Additional Regulations**

- BMP-12: Only vacuum sanders are allowed in the boatyard. Non-vacuum grinders are prohibited.
- BMP-13: Abrasive grit blasting and ice blasting are prohibited.
- BMP-14: The use of antifouling paint containing Tributyltin (TBT) is prohibited. The marina encourages the use of low-copper or non-copper bottom paints.

- **BMP-15**: Used **zinc anodes** must be **placed in the designated recycling container** and not disposed of in the water or trash. Marina staff can assist with proper disposal.
- BMP-16: Spray painting is prohibited on-site.
- BMP-17: Tenants and boat owners are responsible for ensuring that all vendors, contractors, and third parties they bring onto the premises comply with these BMPs, as well as all applicable environmental laws and marina policies.
